Subject: Contract No. 7008E Amendment: Hanson Bridgett LLP for Legal Services

RECOMMENDATION

Adopt a Resolution authorizing the City Manager to amend the existing Contract No. 7008E with Hanson Bridgett LLP (hereinafter "Hanson Bridgett") by increasing expenditure authority in an amount not to exceed \$40,000 for legal services pertaining to federal and state tax issues.

FISCAL IMPACTS OF RECOMMENDATION

Funding is expected to be expended over the current and next Fiscal Year. Funding for this amendment is available in an allocation from the FY 2013 General Fund and funding will be allocated in the Fiscal Year 2014 General Fund.

The Contract Management System number is CMS No. FEP7A. The City has outstanding invoices from Hanson Bridgett for \$7,600 through the February billing period that must be paid.

CURRENT SITUATION AND ITS EFFECTS

The City has sought the services of outside counsel to provide opinion and advice on several matters pertaining to the impact of federal and state tax laws on employee benefit matters. On May 31, 2001, the City entered into a contract with the law firm of Hanson Bridgett to advise the City on employee benefits and compensation matters that have federal and state income tax implications. Robert Blum, a partner with Hanson Bridgett, is the attorney in charge of the engagement.

Most recently, the City has used the services of Hanson Bridgett to assist the City on clarifications of the Police Retiree Premium Assistance Plan Document and Trust Agreement that affect employees represented by the Berkeley Police Association who retire on or after September 19, 2012, and other benefit issues with tax implications.

BACKGROUND

The original contract for services entered into on May 31, 2000 and the City Council has approved additional contracts with Hanson Bridgett on May 14, 2002 (Resolution No. 61,543-N.S.); on September 9, 2003 (Resolution No. 62,204-N.S.); on March 23, 2004 (Resolution No. 62,411-N.S.); on September 21, 2004 (Resolution No. 62,645-N.S.); on July 12, 2005 (Resolution No. 62,985-N.S.); on January 16, 2007 (Resolution No. 63,548-N.S.); on April 22, 2008 (Resolution No. 64,025-N.S.); on April 21, 2009 (Resolution No. 64,397-N.S.); on April 20, 2010 (Resolution No. 64,833-N.S.); and on October 2, 2012 (Resolution No. 65,905-N.S.).

While the principal reason for the use of tax counsel has been as described above, the City Council should know that this is not the exclusive tax and benefit work performed by Hanson Bridgett for the City. From time to time, staff consults with tax counsel on various benefit and payroll matters and obtains legal advice to ensure the City is in compliance with State and Federal tax and benefit law. This is a very technical field of legal work with frequent exchanges in legislation, court rulings, and regulations promulgated by the Internal Revenue Service and the Governmental Accounting Standards Board.

RATIONALE FOR RECOMMENDATION

It is necessary for the City to provide employee benefits in a manner that complies with various Federal and State laws, rules, and regulations. In order to ensure that the City is in compliance, it is appropriate for the City to contract for specialized legal services to advise the City and to act on behalf of the City when dealing with tax counsel with outside firms.

ALTERNATIVE ACTIONS CONSIDERED

An alternative would be for the work to be performed by the City Attorney's Department. However, the nature of this work involves specialized knowledge of Federal and State tax laws, rules, and regulations and the City Attorney believes that this specialized legal work should be performed by outside counsel.

CONTRACT NO. 7008E AMENDMENT: HANSON BRIDGETT LLP FOR LEGAL SERVICES

WHEREAS, from time to time the City enters into agreements with employee organizations on health and welfare benefit matters that require technical opinion, advice and services on the impacts of these benefits on federal and state income tax withholding; and

WHEREAS, the law firm of Hanson Bridgett LLP (hereinafter "Hanson Bridgett") has staff with the requisite technical knowledge, skills and abilities to provide such opinions, advice and services; and

WHEREAS, the City does not have staff that can provide such opinion, advice and services; and

WHEREAS, Hanson Bridgett was selected to provide these services based on the technical knowledge, skills and abilities of the attorney in charge of the engagement; and

WHEREAS, funds are available in the current year budget and will be appropriated in the next fiscal year's budget in the General Fund, budget code 010-9701-410-3038 and a contract has been entered into the City's contract database, and assigned CMS No. FEP7A.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Berkeley that the City Manager is authorized to amend Contract No. 7008E with Hanson Bridgett for legal services by \$40,000, Budget Code 010-9701-410-3038. A record signature copy of said contract and any amendments to be on file in the Office of the City Clerk.
