FISCAL IMPACTS OF RECOMMENDATION

No General Fund impact; funds are available from Councilmember Arreguín's Council Office Budget discretionary accounts.

BACKGROUND:

The 17th Annual Chocolate and Chalk Art Festival will be held on June 1, 2013. The event, which will be held for the fourth year along the North Shattuck commercial district, takes place from 10:00 am to 5:00 pm. The event will feature chalk art drawings along North Shattuck sidewalks; anyone who would like to participate free of charge is assigned part of the sidewalk to create chalk drawings. There will be a Chalk Art Contest in which all drawings will be judged and winners selected. The event also features a chocolate festival, which will include the tasting of chocolate within various businesses along North Shattuck.

This event is a fun and colorful way to bring the community together, showcase local artists, create public art and support local businesses by highlighting one of Berkeley's most unique commercial districts. 
WHEREAS, Councilmember Jesse Arreguin have surplus funds in his office expenditure account (budget code 010-0242-410); and
