### **CURRENT SITUATION AND ITS EFFECTS**

On July 24, 2013, at the first meeting of the newly-consolidated Parks and Waterfront Commission, the Commission decided to engage Berkeley residents in a discussion of potential improvements to City parks and programs through a series of additional commission meetings in the fall of 2013. Council approval is required for additional commission meetings over and above the ten meetings per year approved by Council per Resolution No. 65,959-N.S., adopted December 11, 2012. On July 24, 2013, the Commission took action to request Council approval of up to four additional meetings of the Parks and Waterfront Commission in 2013 (M/S/C: Catalfo/Boland); Aye's: Boland; Brostrom; Brower; Catalfo; McGrath; McKay; Noe's: none; Abstain: none; Absent: Mester; Veneziano.

### BACKGROUND

On December 11, 2012, Berkeley City Council adopted Resolution No. 65,959-N.S. that established a Commission Meeting Frequency Schedule for 2013. At that time, the Parks and Recreation Commission was allocated ten meetings per calendar year. Any additional meetings require Council approval. Since the start date of the successor commission – the Parks and Waterfront Commission – was July of 2013, the schedule allows a total of five meetings for the second half of calendar year 2013.
